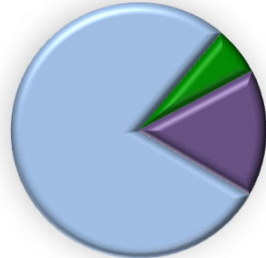


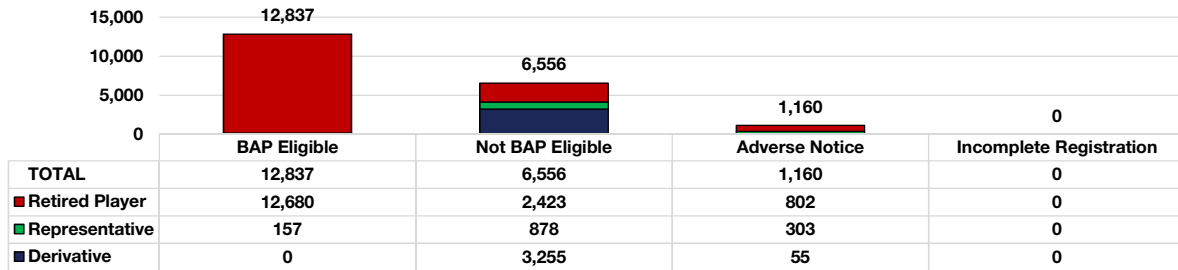

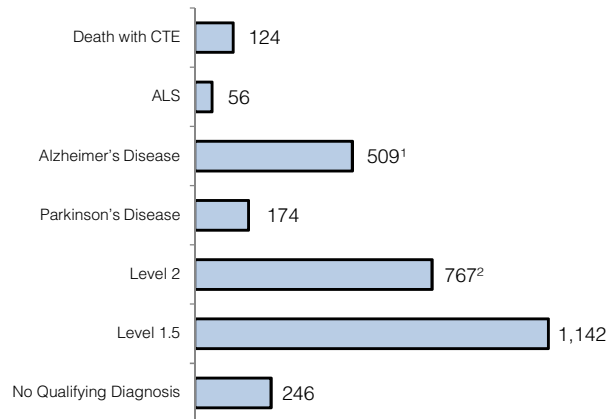
SECTION 3: MONETARY AWARD CLAIMS SUBMITTED: 3,018¹

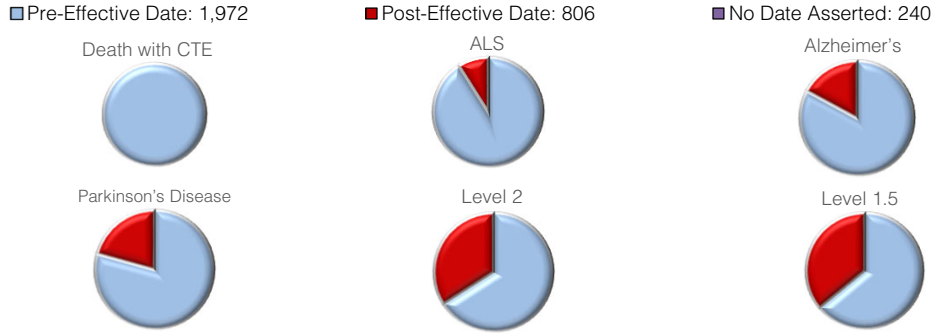

SECTION 4: QUALIFYING DIAGNOSIS ASSERTED IN MONETARY AWARD CLAIMS

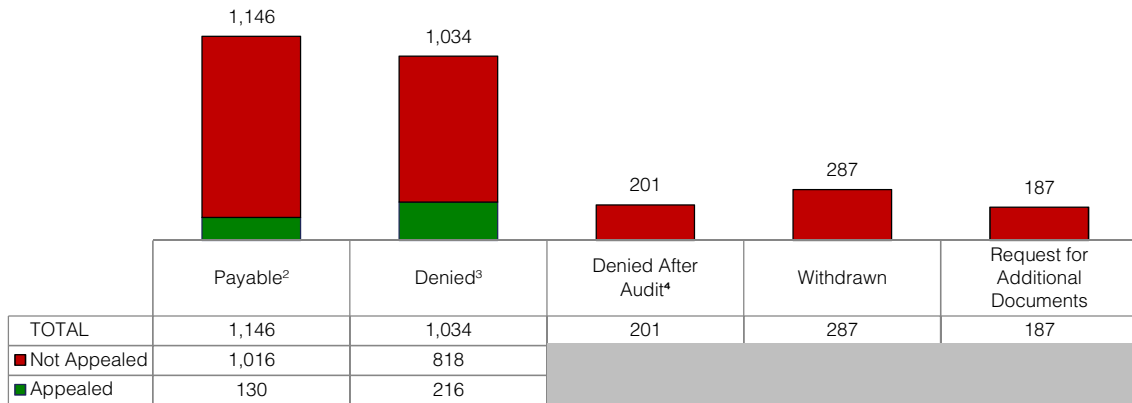

SECTION 6: NOTICES ISSUED ON MONETARY AWARD CLAIMS: 2,855¹



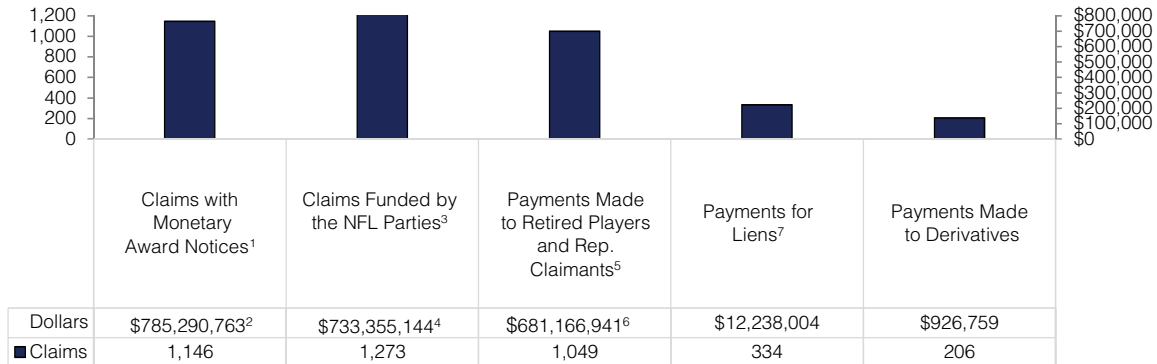
